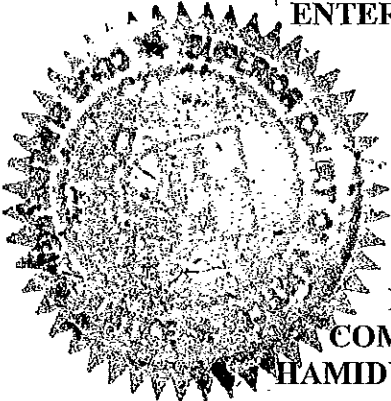

ORDER



THIS MOTION, made by the Plaintiffs, was heard this day at the City of Toronto, Ontario.

ON READING the consent of the plaintiffs, by their solicitors, and of the defendants Cybernet Communications Inc. ("Cybernet"), Switchworks Technologies Inc. ("Switchworks"), and Rick Ross ("Ross"), filed,

1. **THIS COURT ORDERS** that Cybernet, Switchworks and Ross, shall, upon notice by the plaintiffs that the defendants Darren Andrew Budd, Yoav Schwartz, Hamid Abbas or Salveo Limited (the "Mygazines Defendants") have breached the terms of the settlement agreement between the plaintiffs and the Mygazines Defendants (the "Agreement"), or the terms of the Order attached to the Agreement as Appendix "A", remove, within 12 hours of the receipt of the notice, any IP addresses, and/or any content owned by the any of the Mygazines Defendants, hosted on Cybernet's, Switchworks' or Ross' servers. Cybernet, Switchworks or Ross shall provide counsel for the plaintiffs with an e-mail address where such notice can be sent, and shall maintain such e-mail address (or any successor e-mail address, to be communicated to counsel for the plaintiffs) for the duration of their contractual relationship with the Mygazines Defendants.


2. **THIS COURT ORDERS** that should Cybernet, Switchworks or Ross breach this Order or the Settlement Agreement signed by Cybernet, Switchworks and Ross in this action on September 8, 2008, the Plaintiffs shall be entitled to recommence this action and to pursue recovery of all damages and costs that have accrued to the date of this Order and which may accrue in the future.
